Organizational Change Approval Document AK940, Division of Lands and Cadastral, Alaska State Office

A. Description of Proposed Change

The Alaska State Office, Division of Lands and Cadastral, will incorporate the Branch of Pipeline Monitoring (BPM) within the Branch of Lands and Realty. The reorganized Branch of Lands and Realty will consist of a single Branch Chief/Deputy Authorized Officer, and three subordinate section chiefs.

Provided below are 1) a summary of personnel actions per this reorganization, and 2) the personnel structure for the reorganized AK941000 – Lands and Realty Branch

1) A summary of the organizational changes and requested personnel actions are as follows:

- Realign the current AK943000 (BPM) Branch Chief and Deputy AO (Vacant, GS-0301-14) position under AK941000.
 - o GS-14 position will serve as Branch Chief for the reorganized AK941, and will report directly to DSD AK940.
 - New position title: "Branch Chief and Deputy Authorized Officer; Lands, Realty and Trans-Alaska Pipeline System."
 - Position will utilize the following classified Position Description (PD):
 AK940000-0007283, Supervisory Lands & Realty-Oil and Gas
 Specialist. Note: PD's organization code should read 'AK941000'.
- Realign the current AK943000 (BPM) Program Analyst (Houston, GS-0343-12) under AK941000.
 - o Position reports directly to AK941 Branch Chief.
- Establish AK941200 as the "Lands and Realty Section."
 - o Realign the following positions under this new Lands and Realty Section (AK941200):
 - The current AK94100 Branch Chief (Mushovic, GS-13)
 - Position becomes the Section Chief for the newly established AK941200; and reports directly to AK941 Branch Chief.
 - Two (2) Navigability section positions (Frost, vice Basner) currently under AK940000,
 - Four (4) Land and Realty section positions (Fencl, Van Massenhove, Schmidlkofer, vice Doores) currently under AK940000,

B. Reasons for Change

The BPM developed a strategic plan in FY 2018, reviewing all roles and responsibilities associated with monitoring the TAPS grant of ROW. Based on the regulatory authorities of other federal and state agencies, a functional matrix was developed that greatly reduced the roles and responsibilities of the BLM and the associated work load for the BPM. The ultimate goal of the reorganization is to provide streamlined management oversight that is more consistent with national policy and guidance for rights-of-way. With reduced BPM staffing, it is not administratively efficient to maintain a Branch-level structure.

C. Budget Implications

There are no significant budget implications to the BLM Alaska to the reorganization.

With this change in management strategy, the BLM Alaska is reducing the number of cost reimbursable, full-time equivalent positions (FTEs) that support and are funded by the TAPS ROW operator Alyeska Pipeline Services Company (APSC). Prior to the reorganization, 25 FTEs (includes 4.5 supervisors) were covered under the cost reimbursable agreement with APSC. Once the described reorganization is implemented, a total of 16.5 FTEs (includes 2.0 supervisors) will remain funded by the cost reimbursable agreement. Additional reductions are anticipated through attrition. Included in these totals are the following FTEs for which BLM Alaska will continue to be reimbursed one-half their full cost:

- DSD/Authorized Officer (AK940)
- Branch Chief (AK941)
- Staff Assistant (AK940)
- ECP/Native Hire EEO (AK915)
- Public Affairs Specialist (AK912)

D. Impact Statement

- 1. Public Involvement: The change will have no impact to the public. No public outreach is necessary and will not be conducted.
- 2. Employee/Agency Involvement: Through development of the BPM's 2018 strategic Plan, management and employees were been made aware of proposed changes and

potential impacts to administrative operations related to BLM oversight of the TAPS ROW.
