The rangers went hands-on with the suspect, who resisted violently, lunging forward off a 7.5' cliff face and dragging one Ranger (b) (7)(C), (b) with her. Both the ranger and suspect sustained injuries. The suspect then fled down the trail to another cliff, where she stayed for several hours before finally returning to the trail. She was transported to the hospital for injury treatment and mental health evaluation. Rangers then arrested the suspect on multiple federal charges.
