PROPOSED ACTION DESCRIPTION AND ANY MITIGATION	The proposed action is to ensure the allotments continue to meet Land Health Standards in accordance with the (Miles City ARMP (as amended), and to renew or transfer preference to issue 99 grazing permits or leases. In accordance with 43 CFR §4130.2(d), the terms of the permits would be for ten years unless the associated base property is controlled through a base property lease. Grazing permits and leases for allotments that are associated with base property leases would be issued for the term of the lease for a period not less than three years, 43 CFR §4110.2-3(4)(f), and a maximum of ten years 43 CFR §4130.2(d). All permits or leases would be issued with no changes to existing grazing schedules, grazing preferences, kind of livestock, percent public land, type of use, or terms and conditions.
	Table 1 includes the grazing authorization numbers, allotment numbers, allotment names, public acres, public AUMs, county, when the allotment was assessed and met Land Health Standards, Management Status, and if the allotment is located in GHMA, PHMA, RHMA, or outside of a sage-grouse Habitat Management Area.

Some of these allotments contain public lands that lie within a sage grouse Priority Habitat Management Area. A "Threshold and Response" alternative consistent with WO IM 2018-023 was analyzed in the 2015 Miles City Field Office Approved Resource Management Plan (ARMP) (as amended) for all grazing allotments in the Miles City Field Office.

The ARMP states "The NEPA analysis for renewals and modifications of livestock grazing permits/leases that include lands within PHMA will include specific management thresholds based

on GRSG Habitat Objectives Table and Land Health Standards (43 CFR, Part 4180.2) and ecological site potential and one or more defined responses that will allow the authorizing officer to make adjustments to livestock grazing that have already been subjected to NEPA analysis."

This threshold and response alternative was analyzed in the ARMP and implemented under MD LG 9: "For allotments in which the Standards for Rangeland Health are not met (including GRSG Habitat), livestock grazing is a causal factor in the failure to meet these standards, and there is no progress towards meeting the Standards in the allotments within 5 years of making management changes, use will be suspended and not re-authorized until Land Health Standards including habitat objectives are attained. Once standards and habitat objectives are met, use will be reauthorized at levels to maintain resource objectives." Non-attainment of land health standards including habitat objectives is considered the threshold and suspension of use until land health standards and habitat objectives are attained is the response.

In addition, FLPMA under Section 402 (h)(1) in conjunction with WO IM 2015-121 and Appendix K of the ARMP allows permit renewal and transfer of grazing permits when certain criteria are met; including achievement of Land Health Standards as amended by Sage-grouse Habitat Objectives on Table 2-6 and if there are no extraordinary circumstances.

COMPLIANCE WITH NEPA

The proposed action described above does not require the preparation of an environmental assessment (EA) or environmental impact statement (EIS), as it has been found to not individually or cumulatively have significant effects on the human environment.

The Proposed Action is categorically excluded from further documentation under the National Environmental Policy Act (NEPA) in accordance with the following: Compliance with Departmental Manual:

- 1. Preference Transfer: 516 DM 11.9 D (1) Approval of transfers of grazing preference
- 2. Permit/Lease Issuance: 516 DM 11.10 B (1)

 The issuance of a grazing permit or lease by the Secretary concerned may be categorically excluded from the requirement to prepare an environmental assessment or an environmental impact statement under the National Environmental Policy Act of 1969 (42 U.S.C. 4321 et seq.) if— (A) the issued permit or lease continues the current grazing management of the allotment; and (B) the Secretary concerned— (i) has assessed and evaluated the grazing allotment associated with the lease or permit; and (ii) based on the assessment and evaluation under clause (i), has determined that the allotment— (I) with respect to public land administered by the Secretary of the Interior— (aa) is meeting land health standards; or (bb) is not meeting land health standards due to factors other than existing livestock grazing.

Compliance with FLPMA Section 402(h)(1) Criteria for Application of Categorical Exclusion used to Issue a Grazing Permit or Lease:

1. The permit or lease continues the current grazing management of the allotment(s).

- 2. A land health assessment and evaluation have been completed in accordance with Manual Handbook H-4180-1.
- 3. The Authorized officer concludes from the findings of the evaluation report that: a. The public land subject to the evaluation is meeting land health standards, or
 - b. The public land subject to the evaluation is not meeting standards due to factors other than current livestock grazing.

Compliance with IM-2015-121:

- 1. Existing grazing is consistent with land use plan and any applicable allotment management plan objectives and decisions. Most recent Evaluation Report and Land Health Determination and any subsequently collected monitoring data documents that the allotment(s) included in the permit meet land health standards or that factors other than existing livestock grazing are the cause for allotment(s) failing to meet the standards.
- 2. The 12 extraordinary circumstances (below) in 43 CFR 46.215 were reviewed and one or more extraordinary circumstances does not exist:

Extraordinary Circumstances

1. Have significant impacts on public health or safety.

Rationale: The administrative update to issue the grazing permits with the existing terms and conditions should not have an impact on the health and safety of the public. The proposed action would fall in accordance with approved Miles City Resource Management Plan 2015, as amended. The allotments would be monitored to ensure that they continue to provide forage for livestock grazing consistent with other resources and uses as part of an ecologically healthy system consistent with multiple use and sustained yield.

2. Have significant impacts on such natural resources and unique geographic characteristics as historic or cultural resources; park, recreation, or refuge lands; wilderness areas; wild or scenic rivers; national natural landmarks; sole or principal drinking water aquifers; prime farmlands; wetlands (EO 11990); floodplains (EO 11988); national monuments; migratory birds; and other ecologically significant or critical areas.

Rationale: Currently there are no impacts on natural resources and unique geographic characteristics as historic or cultural resources; park, recreation, or refuge lands; wilderness areas; wild or scenic rivers; national natural landmarks; sole or principal drinking water aquifers; prime farmlands; wetlands; floodplains; national monuments; migratory birds; and other ecologically significant or critical areas on the allotments.

Extraordinary Circumstances

A total of 81 of the allotments are in a sage-grouse Habitat Management Area (HMA) identified by the 2015 MCFO ARMP. 52 allotments are in a General Habitat Management Area (GHMA), 19 allotments are in a Priority Habitat Management Area (PHMA), 5 are in a Restoration Habitat Management Area (RHMA), 2 are in both GHMA and PHMA, 2 are in both PHMA and RHMA, and 1 is in both GHMA and RHMA, 19 are not in any HMA. However, this is an administrative action with no changes onthe-ground and therefor there are no expected impacts to sage-grouse or their habitat.

3. Have highly controversial environmental effects or involve unresolved conflicts concerning alternative uses of available resources [NEPA section 102 (2) (E)].

Rationale: Current records indicate there are no highly controversial environmental effects or unresolved conflicts concerning alternative uses of available resources. The proposed action is to issue the grazing permits that continue the current grazing management. Current and past livestock grazing within the allotments has not had highly controversial environmental effects or involved unresolved conflicts concerning alternative uses of available resources. The nature of effects associated with authorizing livestock grazing in the allotments is well understood. Rangeland health assessments were completed and the public land subject to the evaluations was achieving the applicable standards for rangeland health. No resource concerns were identified on the allotments that would require changes to the authorized use.

4. Have highly uncertain and potentially significant environmental effects or involve unique or unknown environmental risks.

Rationale: There would be no significant environmental effects or risks. Livestock grazing is well established and a highly analyzed use of public lands. Based on the interdisciplinary review, new circumstances were not identified, and the consequences of the proposal remain certain. The BLM will follow current applicable guidance including the BLM's 1997 Record of Decision for Standards for Rangeland Health and Guidelines for Livestock Grazing Management.

5. Establish a precedent for future action or represent a decision in principle about future actions with potentially significant environmental effects.

Rationale: The proposed action is an administrative action and would not establish precedent for future action and does not represent a decision in principle about future actions with potentially significant environmental effects because it complies with current Federal Regulation and would not authorize new resource uses beyond what currently exist.

Extraordinary Circumstances

Issuing this grazing permit has met the criteria listed in the Federal Land Policy and Management Act of 1976: 43 U.S.C. subpart 17-7, et seq, section 402(h)(1): the permit issued as a result of this grazing preference transfer will have the same terms and conditions as the previous permit and continues current grazing management on the allotment; the rangeland health assessment and evaluation has been conducted in accordance with H-4180-1; and it was determined the public lands subject to the assessment and evaluation were meeting all applicable Land Health Standards (43 CFR 4180).

6. Have a direct relationship to other actions with individually insignificant but cumulatively significant environmental effects.

Rationale: Implementation of the proposed action does not have any known direct relationship to other actions with individually insignificant but cumulative significant environmental effects. The effects of grazing on the allotments were considered within the context of livestock grazing on both private and BLM managed land and the public land subject to the evaluation in the allotments are meeting rangeland health standards.

7. Have significant impacts on properties listed, or eligible for listing, on the National Register of Historic Places as determined by either the Bureau or office.

Rationale: The proposed action is administrative in nature only and may be exempted from cultural resources inventory under BLM Cultural Resources Handbook H-8110-1, Appendix 1, Range 1. This exemption allows the BLM to waive cultural resources inventory for actions such as permit renewals, transfers, or modifications that have no associated new ground disturbing activities. A search of BLM records and the Montana Cultural Resource Database show that 3 areas of critical environmental concern (ACEC), 159 known historic properties, and 45 paleontological localities are located on BLM-administered surface lands within the allotments. However, as grazing in the allotments is currently authorized and ongoing, no changes to AUMs are proposed, and no new ground disturbance is proposed, new impacts to cultural resources are not anticipated. The BLM has determined that there would be no historic properties affected as a result of authorizing the proposed undertaking. See BLM Cultural Resources Project No. MT-020-23-025.

8. Have significant impacts on species listed, or proposed to be listed, on the List of Endangered or Threatened Species, or have significant impacts on designated Critical Habitat for these species.

Rationale: Some of the allotments are expected to have habitat and known occurrences of several T&E species, including the northern long-eared bat, piping plover, whooping crane, and the candidate monarch butterfly. Regardless, this is an administrative action with no proposed changes to livestock use within the allotment.

Extraordinary Circumstances

There would be no changes on the ground and thus no loss, degradation, or change to habitat for any species. The allotments are expected to continue to meet Standards for Rangeland Health.

9. Violate a Federal law, or a State, local or tribal law or requirement imposed for the protection of the environment.

Rationale: The proposed action is an administrative action and would not violate a Federal, State, local, or tribal law or requirement imposed for the protection of the environment. It complies with current Federal Regulation and will not authorize new resource uses beyond what currently exist.

10. Have a disproportionately high and adverse effect on low income or minority populations (EO 12898).

Rationale: The proposed action considered in this analysis has not resulted in any identifiable effects or issues specific to any minority or low-income population or community as defined in Executive Order 12898 and will not authorize new resource uses beyond what currently exist.

11. Limit access to and ceremonial use of Indian sacred sites on Federal lands by Indian religious practitioners or significantly adversely affect the physical integrity of such sacred sites (EO 13007).

Rationale: There are places within and near the grazing allotments that are known to be of religious or cultural concern to Native American tribes; however, issuance of the grazing permits would not affect use of or access to public lands by Native American tribes with historical or religious ties to the area. The action is administrative and would therefore cause no new impacts to any potential locations of cultural or religious concern in the vicinity.

12. Contribute to the introduction, continued existence, or spread of noxious weeds or non-native invasive species known to occur in the area or actions that may promote the introduction, growth, or expansion of the range of such species (Federal Noxious Weed Control Act and EO 13112).

Rationale: The issuance the grazing permits would not contribute to the introduction, existence, or spread of noxious weeds or invasive species known to occur in the area.
