#### **10:45 Treated Articles and Seed Issues: EPA will discuss plans to regulate Treated Articles and Seeds, and respond to SFIREG's Issue Paper and Letter from August 31 2022, State Lead Agencies will discuss Issues with Treated Seeds, Topics that have been come up, status of treated seed management and regulation.**

Linda, Quinn, Sue, Julie and Amber listed on the agenda. We spoke to Katlin P. last week and said we would have a response to their issue paper in next quarter. We can discuss any issues they might have about our response to the treated seed that went out, but it will take time to fully response to their issue paper. Katlin was ok with our timeline and was to inform them of our position.

#### **11:00 Status of EPA Regulatory and Risk Assessment Processes for Glyphosate, Paraquat, and Diuron**

Kelly: For now, there isn't anything to discuss related to paraquat. We have completed the ID and in August 2022 we stamped/approved labels incorporating the mitigation from the ID. The only outstanding issue is the pending litigation, and possible remand related to that. But we can't discuss that yet b/c we don't know how that is going to come out. So maybe paraquat should come off of that list; we could discuss once there has been more progress on the litigation.

Cathryn: The glyphosate/paraquat/diuron topic Kelly mentioned – we also don't have any updates to share on glyphosate at this time. We can field questions but the ID withdrawal memo includes the latest information. Otherwise I'm not sure what more we can say.

Kevin: Mostly just that I would attend for PFAS to listen and Theo could be available for diuron
