MEMORANDUM FOR RECORD

SUBJECT: Permanent Change of Station (PCS) of Terry Boone, Chief, Environmental Resources Department, US Army Garrison, Alaska (USAG-AK)

- 1. Based on the request from Terry Boone for early release from his transportation agreement in order for him to exercise his reemployment rights to his former place of employment at HQDA (AEPI), USAG-AK agrees to release Terry Boone from his current transportation agreement and issue him permanent change of station (PCS) orders from USAG-AK to HQDA (AEPI). PCS entitlements shall be in accordance with Volume 2 of the Joint Travel Regulations for return from overseas travel. Any entitlements which are discretionary for the losing organization shall be authorized at the same level as were listed on his PCS orders to Alaska (Travel Order #PW-08-002). Orders will be issued IAW current procedures.
- 2. Terry Boone agrees to exercise his reemployment rights and depart USAG-AK, effective the first day of the first pay period in January 2006.
- 3. Terry Boone agrees to not disclose any specific information regarding the PCB matter at TAKU Gardens, excepting with others in his chain of command, counsel (only if there appears a need for him to retain counsel), an Inspector General, or unless specifically requested by competent authorities, such as the Environmental Protection Agency or the Alaska Department of Environmental Conservation.
- 4. Terry Boone agrees to continue to abide by USAG-AK guidance to avoid involvement/intervention in the TAKU Gardens matter during his remaining time as Chief, Environmental Resources Department at USAG-AK.
- 5. USAG-AK agrees that there will be no efforts made to discipline or otherwise adversely affect Terry Boone's career or standing in the Army so long as he departs USAG-AK by the first day of the first pay period in January 2006. If any disciplinary action is pending at the time this agreement is signed it will be canceled upon PCS of Terry Boone.
- 6. USAG-AK agrees to allow Terry Boone to remain in his current position. Terry Boone agrees to abide by the duties indicated on his support form IAW guidelines outlined by Mr. Al Lucht, his immediate supervisor.
