A BILL

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

Councilmember Yvette M. Alexander and Councilmember Marion Barry introduced the following bill, which was referred to the Committee on _____.

To amend the Jobs for D.C. Residents Amendment Act of 2007 to require that all agencies and instrumentalities give qualified District resident applicants a 20-point preference over qualified non-District resident applicants.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the “D.C. Residents Point Preference Amendment Act of 2013”.

Sec. 2. Section 101(a) of the Jobs for D.C. Residents Amendment Act of 2007, effective February 6, 2008 (D.C. Law 17-108; D.C. Official Code § 1-515.01(a)), is amended by striking the number “10” wherever it appears and inserting the number “20” in its place.

Sec. 3. Fiscal impact statement.

The Council adopts the fiscal impact statement in the committee report as the fiscal impact statement required by section 602(c)(3) of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 813; D.C. Official Code § 1-206.02(c)(3)).

Sec. 4. Effective date.

1 This act shall take effect following approval by the Mayor (or in the event of veto by the
2 Mayor, action by the Council to override the veto), a 30-day period of Congressional review as
3 provided in section 602(c)(1) of the District of Columbia Home Rule Act, approved December
4 24, 1973 (87 Stat. 813; D.C. Official Code § 1-206.02(c)(1)), and publication in the District of
5 Columbia Register.
