Re: Petition to Investigate Potential Violations of the Federal Clean Water Act That May Require Withdrawal of Approval for the Florida, Department of Environmental Protection to Administer NPDES Permitting.

Dear Ms. Wilkes:

I wanted to take this opportunity to provide you with additional documentation that we just received from the Executive Office of the Governor of the State of Florida in follow-up to our reply dated May 20, 2011, on the above-captioned issue.

We requested that the Governor's Office provide us with Mr. Vinyard's submissions to them in support of his appointment to the position of the FDEP's Secretary. Yesterday we received two documents from the Governor's Office, both of which are attached hereto. The first is Mr. Vinyard's resume, which clearly states his position as "Director of Business Operations, BAE Systems Southeast Shipyard (formerly Atlantic Marine Shipyards). The resume states that in this position he counseled the company "on major environmental permitting decisions" among which was an NPDES issue involving the St. Johns River. The second document is Mr. Vinyard's formal application for the position of FDEP Secretary. This application lists the same company, BAE Systems Southeast Shipyard, as his employer and, indicates that he had been employed there for the past 5

years as a "Director/VP/Attorney." See, Answer to Question 15 of Response. Under Question 17 of the same application Mr. Vinyard once again listed his involvement with NPDES permitting decisions.

Simply stated, these two documents directly contradict the response given to you by Secretary Vinyard, through counsel. This obvious effort to mislead the EPA only serves to underscore our position that he should be disqualified from having any involvement in Clean Water Act decisions involving the State of Florida.

Thank you for your kind assistance in this matter.
