- **Robert Fields'** career with the National Wildlife Refuge System as a Refuge Supervisor spans a total of 37 years. He served as a Refuge Manager Trainee at the National Bison Range from February 1962 to November 1963 before managing several other Refuges. In retirement Mr. Fields is volunteers his time with the Blue Goose Alliance and the Friends of Midway Atoll.
- **Marvin Kaschke** worked for the Fish and Wildlife Service for 20 years as a Refuge Manager. He was the Manager at the National Bison Range from 1968 to 1977.
- **Joseph Mazzoni** worked for the Fish and Wildlife Service from June 1957 through January 1997; nearly 40 years. He was the Refuge Manager at the National Bison Range from May 23, 1965 to December 1968.
- **Jon Malcolm** was a National Wildlife Refuge Manager for 32 years and was the manager of the National Bison Range from 1981 to 1994; 13 years. He volunteered at the National Bison Range a further 8 years after retiring.
- **Delbert (Skip) Palmer** worked at the National Bison Range in the maintenance department for 16 years until his retirement at the end of 2015. In retirement Mr. Palmer still regularly attends meetings at the National Bison Range and manages 20 acres of his own for use as habitat for wildlife.
- **Marvin Plenert** worked for the Fish and Wildlife service for 32 years spanning from 1962 as a wildlife biologist until 1994 when he was the Regional Director stationed in Portland Oregon. Mr. Plenert spent almost ten years in the Denver Regional Office as Deputy Assistant Director for Refuges from 1977 to 1986 when he transferred to DC and served as the Assistant Director with responsibilities for administration of all refuges in the National Wildlife Refuge System; a position in which he served until 1989.
- **Don Redfearn's** career with the Fish and Wildlife Service spanned over 32 years from 1950 until his retirement in 1982. During this time he managed and/or supervised 31 National Wildlife Refuges. Post retirement Mr. Redfearn has visited more than 100 national wildlife refuges, including the National Bison Range. Mr. Redfearn is also a founding member and past President of the Blue Goose Alliance.
- **William Reffalt's** career spans 39 years between the National Wildlife Refuge System and The Wilderness Society. Mr. Reffalt began his career with the Fish and Wildlife Service in 1960 when he worked at several different national wildlife refuges. In 1984 Mr. Reffalt accepted a position as the Director of National Wildlife Refuge Programs with The Wilderness Society where he worked on all aspects of the Refuge System from management policies to land acquisitions until his retirement in 1999. In retirement Mr.

Reffalt was a founding member of the Blue Goose Alliance and spends countless hours researching and advocating for the National Wildlife Refuge System.

- **David Wiseman** worked for the Fish and Wildlife Service as a Refuge Manager and Refuge Supervisor from 1977 until 2007; 30 years. He was the refuge manager at the National Bison Range from 1995 until 2004. From 2004 until his retirement in 2007 Mr. Wiseman was the Refuge Supervisor in the Denver Regional Office where he was responsible for all operations of five refuges and the wetland management district in northwest Montana.
- **Susan Reneau** has been an author and magazine columnist writing on issues concerning wildlife conservation and big game hunting for over 38 years. Ms. Reneau has written and volunteered extensively on issues concerning the National Bison Range and its management.
