A complaint has been filed in this court which accuses you, ALLEN GRAVES, and charges that in Greenlee County:

**COUNT ONE: CRUELTY TO ANIMALS, A CLASS ONE MISDEMEANOR**

Between the 26th day of May 2016 and the 24th day of June 2016, the defendant, ALLEN GRAVES, recklessly subjected an animal under the person's custody or control to cruel neglect or abandonment, to wit: a mule "little bit", a class one misdemeanor, in violation of A.R.S. §§ 13-2910(A)(1), 13-301, 13-302 and 13-303.

**COUNT TWO: CRUELTY TO ANIMALS, A CLASS ONE MISDEMEANOR**

Between the 26th day of May 2016 and the 24th day of June 2016, the defendant, ALLEN GRAVES, recklessly inflicted unnecessary physical injury to an animal, to wit: a mule "little bit", a class one misdemeanor, in violation of A.R.S. §§ 13-2910(A)(3), 13-301, 13-302 and 13-303.

**COUNT THREE: CRUELTY TO ANIMALS, A CLASS ONE MISDEMEANOR**

Between the 26th day of May 2016 and the 24th day of June 2016, the defendant, ALLEN GRAVES, recklessly subjected an animal to cruel mistreatment, to wit: a mule "little bit", a class one misdemeanor, in violation of A.R.S. §§ 13-2910(A)(4), 13-301, 13-302, and 13-303.

**COUNT FOUR: CRUELTY TO ANIMALS, A CLASS ONE MISDEMEANOR**

6 **COUNT EIGHT: CRUELTY TO ANIMALS, A CLASS ONE MISDEMEANOR**

7 Between the 26th day of May 2016 and the 24th day of June 2016, the defendant,  
8 ALLEN GRAVES, recklessly inflicted unnecessary physical injury to an animal, to wit: a  
9 horse "snip", a class one misdemeanor, in violation of A.R.S. §§ 13-2910(A)(3), 13-301,  
10 13-302 and 13-303.

11 **COUNT NINE: CRUELTY TO ANIMALS, A CLASS ONE MISDEMEANOR**

12 Between the 26th day of May 2016 and the 24th day of June 2016, the defendant,  
13 ALLEN GRAVES, recklessly subjected an animal to cruel mistreatment, to wit: a horse  
14 "snip", a class one misdemeanor, in violation of A.R.S. §§ 13-2910(A)(4), 13-301, 13-302,  
15 and 13-303.

16 YOU ARE SUMMONED to appear at the Justice of the Peace Office in Clifton, Arizona,  
17 at 3:00 p.m. on May 18, 2017.

18  IF THIS BOX IS CHECKED, YOU ARE FURTHER ORDERED to call ahead  
19 and schedule an appointment with the GREENLEE COUNTY JAIL at 928-865-4159 to be  
20 fingerprinted and photographed, at least five (5) days prior to your court appearance date.  
21 Fingerprinting is done on Wednesdays from 8:30 am to 6:30 pm and on Thursdays from 8  
22 to 11 am. This will take about an hour to complete. TAKE THIS SUMMONS WITH YOU  
23 AND SHOW IT TO THE BOOKING OFFICER AT THE GREENLEE COUNTY JAIL.  
24 YOU WILL ALSO NEED A FORM OF IDENTIFICATION.

25 IF YOU FAIL TO APPEAR AS REQUIRED HEREIN, A WARRANT WILL BE  
26 ISSUED FOR YOUR ARREST.
